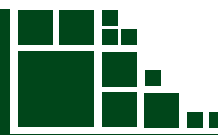

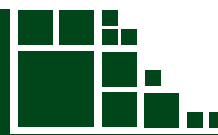
FLAVIO DE LEÃO PEREIRA Ph.D.

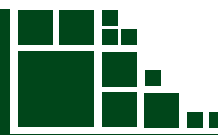


MARCOS JORGE CATALAN, Ph.D.

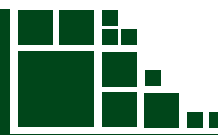
ZÉLIA LUIZA PIERDONÁ, Ph.D.
